## INSTRUCTIONS TO AUTHORS January 2006

**Davidsonia** is a print and electronic journal of botanical gardens science. It publishes original, review, discussion or summary work that is of interest to the botanical, botanical garden and natural history communities at large.

### Submission

All submissions must be accompanied by a covering letter indicating the agreement of all authors to the submission. The manuscript text should be submitted electronically, as a Microsoft Word file. Paper submissions (original plus 2 copies) are satisfactory if authors do not have electronic access. Authors who are submitting illustrations must provide two (2) paper copies of illustrations and tables for use by the peer reviewers. Authors who have not selected illustrations should indicate in the text where they think an appropriate illustration should be inserted. **All parts** of submitted articles **must be double-spaced**. There is no upper word limit, but authors should consult the Editor if their manuscript exceeds 7,000 words. Manuscripts should not be currently under consideration by another journal. All submissions should have the explicit approval (signature or other verifiable device) of all authors.

### General format.

Manuscripts should be arranged in an appropriate form for their content. Primary research papers should be presented with Abstract (50-100 words), Introduction, Methods, Results, Discussion, Acknowledgements, Bibliography. Review, Discussion and Summary papers should be sub-divided in a logical and coherent fashion that makes the paper reader-friendly. All manuscripts should contain an Abstract. Authors should submit original illustrations as appropriate, but the journal has a substantial archive of photographic and original artwork that is available for possible inclusion. The final electronic and paper texts are printed in Garamond font.

## Typographic format

Botanical names in italics, e.g. *Magnolia sargentiana* var. *robusta*.

Cultivar names in single quotation marks, e.g. *Genista pilosa* 'Vancouver Gold'.

Generally, the scientific name should precede the common name in the text, e.g. *Acer griseum* (paperbark maple).

Book titles in text should be in italics.

## References

References should be cited in text by author and year, using et al. for citations with more than 2 authors, e.g. Brayshaw 1996; Pojar and Mackinnon 1994; McCallum et al. 2000.

Citations should be unabbreviated as follows:

### Journal

McCallum, B.D., Harder, D.E., and Dunsmore, K.M. 2000. Stem rusts on wheat, barley and oat in Canada in 1998. *Canadian Journal of Plant Pathology* 22: 23-28.

### Book

Brayshaw, T.C. 1996. *Trees and shrubs of British Columbia*. Vancouver/Victoria: UBC Press/Royal British Columbia Museum.

### Edited Book Chapter

Wilson, E.O. 1991. Biodiversity, Prosperity and Value. *In Ecology, Economics, Ethics: The Broken Circle*. Edited by F.H. Bormann and S.R. Kellert. Yale University Press, New Haven. pp. 3-10.

### Online Citation

Author's Last Name, Initial(s). Date of document [if different from date accessed]. Title of document. Title of complete work [if applicable]. Version or File number [if applicable]. Edition or revision [if applicable]. Protocol and address, access path, or directories (date of access).
